Minutes of the Meeting held on 6 May 2025

1. Apologies - Richard llett and Tim Mustill

2. Minutes of the previous meeting.

The minutes of the SCM held on 10 April 2025 were accepted in full.

Matters Arising

- 2.1 The proposal that a free bucket of balls be offered when the course is closed, will now be taken up again once the current club plans for the development of the range have progressed. Planning permission has been applied for with regard to bringing in soil and materials to raise, and to level the range field.
- 2.2 The issue concerning the stroke indices associated with the Colbalt tees has been discussed with AB. Now that substantial playing evidence is available, new indices will be allocated when a fresh set of cards need to be printed. The date of this is unknown.

All other matters arising were either completed or addressed later in the meeting.

3. Feedback from General Committee meetings

At the most recent meeting of the General Committee consideration was given to the following issues:

- 3.1 It was decided that the Seniors would trial the use of winter mats to preserve fairways during prolonged wet conditions. Although no date was agreed it is expected that this will start in November.
- 3.2 The club will hold a 'Virtual Pro-Am' event on 10 May. It is also planned to hold a similar 'ghost' event during the Open in July. The Seniors will explore the possibilities of staging their own similar event.
- 3.3 The Ladies section have requested that the ditches on the 4th and 16th be re redesigned to incorporate sleepers and gravel. No decision has been made but the Seniors representatives rejected the idea.

4. Treasurer's Report

The new Treasurer is now installed and recognised/accepted by the bank as a signatory on the Seniors bank account. He is awaiting a PIN number from the Bank for access to the account.[Type here]

The latest accounts to 4th May 2025 show the bank balance currently stands at £2,501.59 and the Income & Expenditure account £810.65, in surplus.

11. AGM Review

The feedback from the AGM was considered to be very helpful.

11.1 Pace of Play

It was agreed to activate the plan to use an individual within each tee group as a 'Pacemaker'. Their responsibility will be to:

11.1.1 encourage the group to keep in touch with the group in front

11.1.2 record the time taken to complete the round, on the card.

Each group will select their own pacemaker and it need not be the person marking a team card.

11.2 New Competition

In the light of the rejection of the proposed changes to the Annual Challenge and Memorial competitions a new event was proposed by RM.

This will be based on the current Twist event, but split over two days in one week. The Tuesday roll-up will be a strokeplay competition and on the Thursday a Stableford competition will be held. Winners for each competition will be identified and prize money awarded. In addition, each player's Stableford score will be subtracted from their net strokeplay score. The person with the lowest score will be deemed to have won the Seniors Masters. They will be awarded a salver and gain entry to the Seniors Champion of Champions event.

This was agreed as a suitable new event and will be trialled in 2025 and represented the AGM in April 2026 for ratification.

12. AOB

- 12.1 CF asked if all Silverware competitions should be played in handicap order. There were different views and it was decided to investigate this further prior to clarification.
- 12.2 It was agreed to form a working party to help organise and manage the Captain's Charity Day to be held 17th July. RM, TM and JP were co-opted.
- 12.3 DH agreed to see if the Summer Eclectic could be set up and managed on ClubV1 and to see if an invitation was required.
- 12.4 DH also asked who had won the club prizes associated with early payment of their subscriptions. Some information was shared but it was vague. It was felt that the club could and should communicate this and other news more effectively.
