

Studley Wood Seniors Committee

Minutes of the Meeting held on 9 October 2025

The meeting opened at 14.01 hrs

In attendance: Jonathan Perks (Chair), Gerry Prickett, Paul Smith, David Hughes, and Russel Matthews.

- 2. Minutes of the previous meeting.**

The minutes of the SCM held on 2 September 2025 were accepted in full.

Matters Arising

All matters arising were either completed or were addressed later in the meeting.

- 3. Feedback from General and Men's Committee meetings**

From the general Committee:

- Fairway, portable mats are due to be trialled by the Seniors in November (18th and 25th roll-ups). Following the trials it will be mandatory to use mats when advised by the club. It is expected that mats will be most needed in December and through to March.
- Standard mats will be available to hire from the club (AB golf have enough material to produce enough mats for the trials). Alternatively, players can use their own mats: AB Golf / SWGC are investigating a source for better quality mats for members to buy.
- Temporary winter tees will be set up on the par threes. It will be possible to insert regular tee pegs into them.
- English Golf have revised the rules regarding pick and place: it will now be necessary to seek permission from BB&O as previously.
- Over the winter, “no access” areas will be staked out rather than roped. All members will need to be vigilant that these restricted areas are respected.
- Micro-coring will start in the week beginning 13th October.
- Matches in the club diary should be transferred to BRS.
- The preparation for the planning application regarding the refurbishment of the driving range is now at its final stage. Trackman will be installed prior to the other proposed changes taking place to enable the range to remain open for as long as possible.

- There is now a full complement of green keepers following a recent appointment.
- The path from the 18th tee is to be repaired.
- The damaged practice net (next to the 1st tee) is to be replaced.
- The importance of repairing divots and the correct placement of rakes in bunkers (see instructions on notice board beside front door) have again been emphasised.

There was no attendance at the Men's committee.

4. Treasurer's Report (Agenda items 4 and 5)

PS had distributed his report prior to the meeting.

- 4.1 He reported that the accounts now include all the roll-up income up until 5 October.
- 4.2 The retained sum from roll-ups was now 8.6% which he considered to be satisfactory.
- 4.3 £50 was still outstanding from the Captain's Charity Day accounts despite the individual debtor being chasing on three occasions.
- 4.4 Summer Eclectic prize money is ready to be disbursed. It will be included in the Order of Merit.
- 4.5 There was surplus per person (approx. £5) on the Bournemouth Tour. This could be paid out individually, but given the inconvenience it was agreed that Chris Perks would seek the permission of the participants to contribute this sum to the captain's charity. **Action: CP**

5. Fixture Secretary's Report

- 5.1 With RI absent there was no formal report, but everything is in order.
- 5.2 The re-arranged home Burford match will be in March 2026. The home Harleyford match also needs to be re-arranged for early next year. **Action JP**

6. Awaydays / Tour Update

- 6.1 See 4.5 above for Bournemouth surplus.
- 6.2 The Spring tour for 2026 was discussed. Four options are being explored with the favourite being a tour on 11 – 13 May. The Cwrt Bleddyn Hotel and Spa would be the base, with rounds at the Monmouthshire, Rolls of Monmouth and Woodlake Park golf courses. Singles would be £375 per person, Twins £315 per person. The Herefordshire golf course was noted as an alternative, probably for Woodlake Park. CP to review and undertake the

organisation. It was noted that it is not necessary to rush this review and that it may be better to sort it out on return from their holiday. **Action: CP**

6.3 Prizes for future tours will be in kind (balls, markers etc.).

7. Proposed roll-up programme for October

7.1 The proposed playing programme for November was agreed.

8. Roll-up & Results Rota

8.1 It was agreed that there would be no provision for contributions to poppy appeal in the roll-up on 11 November. Members have ample opportunity to contribute separately, not least the poppy appeal on the bar.

8.2 The Order of Merit is currently being led by Bob Clarke.

8.3 It was agreed that the bronze tees can be used more in the winter months, as there seemed to be a general dislike of playing off the Cobalt tees.

9. Competitions and Matches

9.1 JP reported that all of the Senior's friendlies had now been completed. The results were: won 10, drew 3 and lost 7. Two home matches had to be abandoned (Burford and Harleyford), and were being re-arranged for early next year. **Action: JP**
